Bye-law No. 7 - Disqualification for member of FISHCOPFED [Section 29 of MSCS Act, 2002]

- (1) No person shall be eligible for being a member of FISHCOPFED if-
- (a) His business is in conflict or competitive with the business of FISHCOPFED; or
 - (b) He used two consecutive years the services below the minimum level specified in the bye-laws; or
 - (c) He has not attended three consecutive general body meetings of the FISHCOPFED and such absence has not been condoned by the FISHCOPFED; or
 - (d) He has made any default in payment of any amount to be paid to the FISHCOPFED; or
 - (e) He has been adjudged by a competent court to be an insolvent or an undercharged insolvent; or
 - (f) Has been sentenced for any offence, other than offence of a political character or in offence not involving moral turpitude and dishonest and a period of five years has not elapsed from the date of expiry of the sentence; or
- (2) Notwithstanding any contained in MSCS Rule or the bye-laws of the FISHCOPFED, if a member becomes or has already become subject to any disqualifications specified in Rule 11 of sub-rule(2), he shall be deemed to have ceased to be a member of FISHCOPFED from the date when the disqualification was incurred.
- (3) FISHCOPFED shall not admit members within thirty days prior to the date of meeting of its general body.
