1. The election for the 14 Board of Directors and Office Bearers (Chairman 1 & Vice-Chairman-1) of the FISHCOPFED will be held in accordance with the provisions contained in the applicable Bye-laws of FISHCOPFED, the Multi-State Cooperative Societies Act, 2002 as amended in 2023, and rules framed thereunder. The detailed election programme is enclosed as Annexure I. A copy of the election notice published in newspapers across the country is enclosed as Annexure II.
2. As per Rule 19 H of the MSCS Rules as amended in 2023 and Clause 15 of the amended bye-laws of FISHCOPFED as per Certificate of Registration of Amendment vide No.- L-11015/17/1974-L&M dated 11.12.2025 of Central Registrar of Cooperative Societies, M/o Cooperation, GOI, the member institutions are required to send the name of their Chairperson or President or the Chief Executive or a duly authorized member of the board of such co-operative society as representative (hereinafter referred to as the delegate) in accordance with the provisions contained in sub-section (3) of section 38 of MSCS Act 2002 as amended in 2023 together with the resolution of the board of the society and the specimen signature of the Chairperson or President or the Chief Executive or duly authorized member of the board, duly attested and bearing the seal of the society in the proforma enclosed as Annexure-III.

3. In accordance with the provision prescribed in sub para (c) of para 1 of the Schedule appended to the Multi State Cooperative Societies Rules 2002, as amended with MSCS Rules 2023, each Member Organisation shall send one delegate. You are, therefore, requested to communicate the name and complete address of the delegate representing your organisation in terms of Section 38(3) of Multi State Cooperative Societies Act, 2002, as amended with MSCS Act 2023, alongwith a certified copy of the fresh resolution of the Board of your organisation together with the specimen signatures of the delegate duly attested and bearing the seal of the Organization in the proforma as mentioned in Annexure III above.

Section 38(3) of the Multi State Cooperative Societies Act, 2002, as amended with MSCS Act, 2023, is reproduced below:

*"Where in any meeting of the General Body or the Board of a Multi State Cooperative Society, a cooperative society or another Multi State Cooperative Society is to be represented, such cooperative society or other Multi State Cooperative Society shall be represented in such meeting only through the Chairperson or the President or the Chief Executive or a Member of the Board of such cooperative society or other multi state cooperative society, as the case may be, if such member is so authorised by the board and where there is no Board of such cooperative society or multi state cooperative society, for whatever reasons, through the administrator, by whatever name called, of such cooperative society or other multi state cooperative society:*

*Provided that where the Bye-laws of a Multi State Cooperative Society provide for representation of other institutions in any meeting of general body or the board of such Multi State Cooperative Society, such institutions shall be represented through its nominee."*

As provided in para 1 (c) of the Schedule referred to hereinabove "Fresh resolution shall be required for every general meeting at which election shall be held."

6. The election to the members of the Board of Directors of FISHCOPFED will be held for the following constituencies in terms of **Bye-laws No.22**: -

22(a): Twelve (12) members-Two representatives to be elected by all the delegates of the general body of the member institutions from each of the following six zones. However, only one representative can be elected from one State/Union Territory in a Zone.

1. North Zone: Haryana, Himachal Pradesh, Jammu & Kashmir, Ladakh Punjab, Rajasthan, Chandigarh and Delhi;
2. West Zone: Goa, Gujarat, Maharashtra, Daman & Diu and Nagar Haveli;
3. Central Zone: Chhattisgarh, Madhya Pradesh, Uttar Pradesh & Uttarakhand;
4. South Zone: Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu, Andaman & Nicobar, Lakshadweep and Puducherry;
5. East Zone: Bihar, Jharkhand, Odisha and West Bengal;
6. North-East Zone: Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura and Arunachal Pradesh.

22 (b): Two representatives to be elected amongst the Statutory Corporations/PSUs of the Government of India having more than 10% share in the FISHCOPFED.

22 (c): Not more than three persons to be nominated by the Central Government based on equity share capital held by the Central Government i.e. one person if the equity share capital is less than 26%, two persons if the equity share capital is more than 26% or more but less than 51%, and three persons if the equity share capital is 51% or more of the total issued share capital.

7. The election of the Board of Directors of FISHCOPFED will be held on **3<sup>rd</sup> July 2026 (Friday)** in the premises of FISHCOPFED Head Office, 7, Sarita Vihar Institutional Area, New Delhi-110076 as per the election programme.

8.
